## Happy Presidents Day—Monday, February 21<sup>st</sup>!

In 1971, Richard M. Nixon made the executive order to pass the Uniform Monday Holiday Act, which shifted Washington's Birthday, Columbus Day, Memorial Day, and Veterans' Day to Monday. With the date landing in the middle of Lincoln's and Washington's birthday, it became known as Presidents' Day, while having a simultaneous benefit for retail stores as they advertised their special sales events during this time. **Committee in place to make recommendations to the Board of Supervisors regarding land use in the county.** Initiated by SCDF, a committee is now in place and at work to advise the Board of Supervisors regarding land use in the county. The committee, chaired by SCDF Vice-President for Community Development Pat Brown, has been well received by the Board of Supervisors, and the committee is coordinating with Central Mississippi Planning and Development District (CMPDD) staff members for their expertise as the long-term project develops. In 2010, a land use plan was a part of a CMPDD-prepared comprehensive plan for the county; however, the plan was never officially adopted.

The closing for the sale was held on January 28, 2022. The 110-acre property is located at Bowen Road and State Highway 43.
